Working in emergency homeless accommodation has taught me so much, from both a professional and emotional standpoint. In this role, I have provided essential support to individuals suffering mental health issues, drug and alcohol addiction, domestic and sexual abuse. This, of course, is very challenging at times but I have found it incredibly rewarding to assist people who have nowhere else to turn.

I have built strong connections with many of those I have supported. For example, last year I supported a young woman who was fleeing domestic and sexual violence. Her mental health had deteriorated and she was driven to drug misuse as a means to cope. Unfortunately, this meant that she had had to give up her children which was of course very distressing for her.

There had never been much stability or anyone she could rely upon to help her. It was important to me to provide her with that constancy, reassurance and guidance she needed whilst on the path to recovery.

I believe that a safe environment with no judgement for individuals to learn about harm reduction and gain access to resources is key.

Too many people that I have supported have been arrested for possession of illicit substances when they are in homeless accommodation. I believe that punishing individuals with health issues does not rehabilitate them in anyway. It creates more issues for that person and moves them further away from seeking help because the general consensus is negative towards people with addictions.

This pilot scheme will transform lives and give vulnerable people a chance to get the help they require.
